YOU ARE HEREBY WARNED THAT YOUR PARTICIPATION THE PARADE AND USE OF ANY EQUIPMENT FURNISHED BY LINCOLN HEIGHTS IS AT YOUR OWN RISK. NO CHILDREN UNDER THE AGE OF SIX ARE ALLOWED TO RIDE ON ANY FLOAT UNIT. Because of the inherent risk arising out of such activities, and the bodily injury or property damage to you and/or to others which may result, Lincoln Heights assumes no responsibility or liability whatsoever for my injury or damage of any nature arising from your participation in the Parade and/or use of any equipment furnished by Lincoln Heights. By signing the Waiver below, you acknowledge that you are voluntarily assuming all risks related to your participation in the parade and use of any equipment furnished by Lincoln Heights, and that you have received, thoroughly reviewed and understand the agreement below.

WAIVER RELEASE AND INDEMNIFICATION AGREEMENT

I acknowledge and agree that my participation in the parade is at my own risk. I am aware that I can be injured as a result of my participation in the parade, whether by my own actions or omissions, the actions or omissions of others, the malfunction of any equipment, or other causes.

In consideration of Lincoln Heights allowing me to participate in the Parade and/or Lincoln Heights furnishing of equipment for my use, I, for myself, my heirs, executors, agents and assigns, hereby waive, release, acquit, and forever discharge Lincoln Heights and its affiliates, directors, officers, administrators, board members, instructors, employees and agents, of and from any and all claims, liabilities, losses, demands or causes of action, of whatsoever nature, whether at law or in equity, which I have or may have or which may hereafter accrue, arising out of any cause, act, omission or event, specifically including but not limited to claims arising out of bodily injury or property damage that I may sustain while participating in the parade or in connection with my use of equipment which is furnished to me by Lincoln Heights.

In further consideration of the foregoing, I hereby agree to and do indemnify and hold harmless Lincoln Heights and its affiliates, directors, officers, administrators, board members, instructors, employees and agents, of and from any and all claims, liabilities, losses, demands or causes of action, of whatsoever nature, at law or in equity, which or may be asserted by any person or entity, for personal property damage or otherwise arising out of any act or omission by me in connection with my participation in the Parade or use of any equipment, whether supplied by me or furnished to me by Lincoln Heights.
