**RESOLUTION IN SUPPORT OF THE LINCOLN HEIGHTS COMPREHENSIVE
DEVELOPMENT CORPORATION COLLABORATING WITH THE HAMILTON COUNTY
REGIONAL PLANNING COMMISSION TO UPDATE THE CIVIC AGENDA**

NOW, BE IT RESOLVED, by the Council for the Village of Lincoln Heights, Hamilton County, Ohio, that:

SECTION I Council hereby declares its support of the Lincoln Heights Comprehensive Development Corporation ("CDC") for the purpose of collaborating with the Hamilton County Regional Planning Commission ("Commission") to update the civic agenda for the Village of Lincoln Heights. Provided, however, the CDC is not intended to replace any of the primary functions of the municipality, including without limitation the provision of safety services, administration, finance, and building and zoning.

SECTION II Nothing in this Resolution shall be construed as a promise or in any way bind the Village to take future actions without Council authorization.

SECTION III This Resolution is hereby declared to be an emergency measure necessary for the health, safety and general welfare of the Village of Lincoln Heights. The reason for said emergency is the need to provide immediate support to the CDC to collaborate with the Commission to update the civic agenda for the Village of Lincoln Heights.
