4. Economic Development: Kathy Goodwin-Williams, Chair, Phyllis Baber and Ruby Kinsey-Mumphrey.
5. Recreation: Phyllis Baber, Chair, Kathy Goodwin-Williams and Frankie C. Dotson.

**SECTION II** All Standing Committees shall meet separately once a month on an assigned day and time to be determined by each Standing Committee. Provided, however, that there shall be no regularly scheduled meeting during the month of August. All of the aforementioned meetings shall take place at Village Hall, unless otherwise noticed.

**SECTION III** All Standing Committees shall provide a written report to Council following their monthly meeting. Said report shall be presented to Council at its second regularly scheduled council meeting of the month. Provided,

however, that the Finance Committee shall provide its report at the first meeting of the month.
