WHEREAS, Pursuant to Section 9.04 of the Village of Lincoln Heights Charter, there shall be established and appointed by Council a Charter Revision Committee consisting of three members; and

WHEREAS, Pursuant to Section 9.04 of the Village of Lincoln Heights Charter, members shall be appointed to a five-year term.


NOW, THEREFORE, BE IT RESOLVED, by Council for the Village of Lincoln Heights, Hamilton County, Ohio, that:


