**FINAL RESOLUTION OF INTENT TO REMOVE THE VILLAGE MANAGER FROM
OFFICE**

WHEREAS, The Council of the Village of Lincoln Heights passed Resolution No. 2018-R-34, Resolution of Intent to Remove the Village Manager from Office, on June 25, 2018 pursuant to Section 3.05 of the Village Charter;

WHEREAS, The Law Director for the Village of Lincoln Heights hand delivered a copy of the aforementioned Resolution to the Manager at Village Hall on June 27, 2018;

WHEREAS, The Village Manager, Rebecca A. Hopkins, did not file with the Clerk of Council a written request for a public hearing or a written reply to the Resolution of Intent;

WHEREAS, Five business days have passed since a copy of the aforementioned Resolution was delivered to the Village Manager, Rebecca A. Hopkins.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the Village of Lincoln Heights, Hamilton County, Ohio,


SECTION I. That Council hereby removes Rebecca A. Hopkins as the Village Manager pursuant to Section 3.05 of the Village Charter effective immediately.

SECTION II. That Donna Pope shall continue as the acting Village Manager pursuant to the Resolution of Intent until Council shall appoint a person to the position of Manager as provided for under the Charter.

SECTION III.

This Resolution is hereby declared to be an emergency measure necessary for the health, safety, and welfare of the residents of the Village of Lincoln Heights. Specifically, its adoption is necessary because of the Manager's improper use of the Village credit card and to continue the appointment of Donna Pope as acting Village Manager to handle administration of the Village's affairs until such time as Council shall appoint a person to the position of Manager.


