**WHEREAS,** Richard Headen's term as Mayor and a Councilmember ended on December 31, 2017.


**NOW, THEREFORE, BE IT RESOLVED** by the Council for the Village of Lincoln Heights, Hamilton County, Ohio, that:

**SECTION I.** US Bank National Association is hereby instructed to remove Richard Headen as an authorized signer from all accounts for the Village effective immediately, including without limitation the general fund account and the Mayor's Court account.

**SECTION II.** Upon passage, the Village Manager shall immediately notify US Bank that Richard Headen is no longer an authorized signer on any accounts for the Village.

**SECTION III.** This Resolution is hereby declared to be an emergency measure necessary for the health, safety and general welfare of the Village of Lincoln Heights. The reason for said emergency is the need to ensure the Village financial affairs are properly cared for.


