**RESOLUTION CLARIFYING PAY INCREASE FOR DONNA POPE WHILE SERVING AS
ACTING VILLAGE MANAGER IN FISCAL YEAR 2018**

- WHEREAS,** The Village Manager, Rebecca A. Hopkins, was removed from office pursuant to Resolution No. 2018-R-40;
- WHEREAS,** Donna Pope was appointed acting Village Manager pursuant to Resolution No. 2018-R-34;
- WHEREAS,** Resolution No. 2018-R-42 authorized a pay increase for Donna Pope while serving as acting Village Manager, effective as of June 26, 2018, in the annual gross amount of \$18,333.00, pro-rated for the rest of calendar year 2018 ("**Pay Increase**");
- WHEREAS,** The language contained in Resolution No. 2018-R-42 resulted in confusion regarding the amount of the Pay Increase; and
- WHEREAS,** Council for the Village of Lincoln Heights, *nunc pro tunc*, hereby amends and revises Resolution No. 2018-R-42 to clarify the amount Donna Pope should have received on a bi-weekly basis for fiscal year 2018 while serving as acting Village Manager.

NOW, THEREFORE, BE IT RESOLVED by the Council for the Village of Lincoln Heights, Hamilton County, Ohio, that:

- SECTION I** Donna Pope shall receive a pay increase, effective as of June 26, 2018, on a bi-weekly basis in the gross amount of \$1,410.23, for fiscal year 2018 while she serves as acting Manager for the Village of Lincoln Heights ("**New Pay Increase**"). The New Pay Increase shall immediately terminate upon Donna Pope no longer serving as the acting Village Manager.
- SECTION II** This Resolution is hereby declared to be an emergency measure necessary for the public health, safety and welfare. The reason for such emergency is the need to properly compensate Donna Pope while she serves as acting Village Manager and to provide legislative authority for such fiscal action.
