**RESOLUTION AUTHORIZING THE VILLAGE MANAGER TO APPLY  
FOR A STATE OF OHIO NATUREWORKS GRANT**

**WHEREAS**, the State of Ohio, through the Ohio Department of Natural Resources, administers financial assistance for public recreation purposes, through the State of Ohio NatureWorks Grant Program; and

**WHEREAS**, the Village of Lincoln Heights, Hamilton County, Ohio desires funding assistance under the NatureWorks Grant Program.

**NOW, THEREFORE, BE IT RESOLVED** by the Council for the Village of Lincoln Heights, Hamilton County, Ohio, that:


**SECTION I.** Council for the Village of Lincoln Heights, Hamilton County, Ohio hereby approves filing an Application for financial assistance under the NatureWorks Grant Program.

**SECTION II.** The Village Manager is hereby authorized and directed to execute and file an Application with the Ohio Department of Natural Resources and provide all information and documentation required to be eligible for possible funding assistance under the NatureWorks Grant Program.

**SECTION III.** Council for the Village of Lincoln Heights, Hamilton County, Ohio agrees to obligate the funds received from the NatureWorks Grant Program which are required to satisfactorily complete the proposed project and become eligible for reimbursement under the terms of the NatureWorks Grant Program.

**SECTION IV.** This Resolution is hereby declared to be an emergency measure necessary for the health, safety and general welfare of the Village of Lincoln Heights. The reason for said emergency is the grant application deadline of June 1, 2019.
