**RESOLUTION AUTHORIZING THE VILLAGE MANAGER TO PURCHASE VEHICLES
FOR THE POLICE DEPARTMENT**

WHEREAS, The Village of Lincoln Heights needs to purchase new vehicles for police functions; and

WHEREAS, The Hamilton County Sheriff's Office provides police protection services for the Village and has identified the 2018 Dodge Charger Police vehicle as the make and model it desires.

NOW, THEREFORE, BE IT RESOLVED, by the Council for the Village of Lincoln Heights, Hamilton County, Ohio:

SECTION I The Village Manager is authorized to purchase two 2018 Dodge Charger Police Vehicles as further detailed on the attached **Exhibit A** for the combined amount of Sixty Thousand Dollars (\$60,000).

SECTION II The aforementioned vehicles will be used for police protection services.

SECTION III This Resolution is hereby declared to be an emergency measure necessary for the health, safety and general welfare of the Village of Lincoln Heights. Specifically, the aforementioned vehicles are necessary for the effective and efficient provision of police protection services.
