**RESOLUTION AWARDING LEGGETT AND SCHUMARD STREET  
IMPROVEMENT PROJECT TO THE J. K. MEURER CORPORATION**

**WHEREAS,** The Village of Lincoln Heights received several bids on February 7, 2019 pertaining to street repairs for Leggett Street and Schumard Avenue being funded by a SCIP Grant ("Project"); and


**WHEREAS,** Pat Madl, the Project Engineer, and CT Consultants, Inc. reviewed the bids and recommended in writing (a copy of which is attached hereto as **Exhibit A**) that the Project be awarded to the J. K. Meurer Corporation.

**NOW, THEREFORE, BE IT RESOLVED,** by the Council for the Village of Lincoln Heights, Hamilton County, Ohio, that:

**SECTION I** The Project is hereby awarded to the J. K. Meurer Corporation for the amount of \$572,246.80.

**SECTION II** This Resolution is hereby determined to be an emergency measure necessary for the health, safety and general welfare of the Village of Lincoln Heights. The reason for said emergency is the need to award the Project to the J. K. Meurer Corporation so that the street repairs for Leggett Street and Schumard Avenue may commence.

On Thursday, February 7, 2019, Bid Proposals received and opened for the above-referenced project. All bids received were in proper form. The breakdown of the Bid Proposals are as follows:

It appeared that Adleta turned in the lowest bid at the bid opening. Upon our review, and despite the noted corrections, J. K. Meurer's total base bid of \$572,246.80 was the lowest bid received. See the attached Bid Tabulation sheet. However, because J. K. Meurer did not enter the base bid total sum, we would recommend that the Village's attorney confirm that the submitted bid from J. K. Meurer is complete and acceptable prior to awarding the contract.

We have worked with J. K. Meurer on projects of similar cost and size and have found their work to be satisfactory and both their business practice and employees to be professional. Therefore, based on our knowledge of the contractor, and upon the Village's attorney approval, we recommend that the Village award the Leggett & Schumard Street Improvements project to J. K. Meurer for their Base Bid of \$572,246.80.
