RESOLUTION ACCEPTING A PUBLIC ENTITIES POOL GRANT OF \$500.00 FOR SAFETY RELATED GOODS AND APPROPRIATING THE GRANT FUNDS

WHEREAS, The Public Entities Pool ("PEP") has awarded the Village of Lincoln Heights, Hamilton County, Ohio ("Village") a Grant of \$500.00 ("Grant") for safety-related goods;

WHEREAS, Ohio Revised Code §5705.42 states that the amount of the Grant shall be deemed appropriated for the purchase of safety-related goods and is deemed in the process of collection within the meaning of Ohio Revised Code §5705.41;

WHEREAS, Ohio Revised Code §5705.41(E) states that revenue in the process of collection shall be deemed in the appropriate fund; and

WHEREAS, PEP requires the Village of Lincoln Heights to submit invoices and documentation for reimbursement for completed deliverables.

NOW, THEREFORE, BE IT RESOLVED by the Council for the Village of Lincoln Heights, Hamilton County, Ohio that:

SECTION I The Village Finance Department is hereby authorized to accept the Grant from PEP for the purchase of safety-related goods.

SECTION II Pursuant to Ohio Revised Code §5705.42 and Ohio Revised Code §5705.41(E), the Grant funds shall be deemed to be in the appropriate funds ("Fund"), and the Finance Director shall record it in the designated accounts as follows:

SECTION III The Grant funds shall be deposited into the Fund, and administered by the Finance Director.

SECTION IV The Village Finance Director is hereby authorized to draw warrants for payments from the Grant funds upon receiving proper certificates and vouchers therefore, approved by the board or officers authorized by law

to approve the same, or an ordinance or resolution of Council to make the expenditures; provided that no warrants shall be drawn or paid for salaries or wages except to persons employed by authority of and in accordance with law or ordinances.
